Notice Regarding Launch of Free Plan for Medical Document Creation Service

FINDEX Inc. (the “Company”), hereby announces that at a Board of Directors meeting held today, the Company decided to launch a free plan for its cloud-based medical document creation service “DocuMaker Cloud” (hereinafter referred to as the “Service”) for specific medical documents. The free plan will be available from August 1, 2025.

Since June 2024, the Company has been providing the Service on a paid basis to support DX (Digital Transformation) in medical institutions. However, to promote and realize medical DX, the Company believes that it is necessary to accelerate the digitization of medical documents through the Service, and has therefore decided to offer the free plan. The Company believes that the wider adoption of the Service will advance medical DX, improve operational efficiency, enhance information sharing, and contribute to public health promotion and higher quality medical services.

While the impact of this matter on this fiscal year’s results is expected to be minimal, this will significantly contribute to enhancing the Company’s corporate value over the medium to long term.

1. Background of the Free Plan Offering

Many existing medical documentation systems are designed for large hospitals. Therefore, they are often not suitable for clinics and small to medium-sized hospitals in terms of both implementation costs and functionality. Moreover, smaller medical institutions have not yet fully implemented digitalized solutions such as electronic medical record systems and medical documentation systems. This lack of digitization poses challenges to information sharing both within and outside the hospital and hinders the development of a foundation for medical DX within Japan.

Under these circumstances, the Company has decided to offer the free plan for the Service that allows medical institutions to easily begin digitizing essential medical documents, without limits on the number of uses or functionality. As a first step toward medical information sharing, this plan will cover commonly used medical documents.

By implementing the Service, medical institutions will be able to digitize “Patient Referral Document”, which are one of the “Three Documents and Six Information Items” stipulated by the government’s medical DX policy to be handled by electronic medical record information sharing services.

3. Future Prospects: Expanding Paid Plans and Enhancing Document Compatibility

In addition to the free plan that supports digitization in clinics and other smaller institutions, the Service also offers paid plan that cover all medical documents offered by the Service. While maintaining the functionality and expandability of the DocuMaker series, which has been highly regarded by university hospitals and core hospitals nationwide, the cloud version is designed for user-friendly operation.

■ Future Vision as a Standard Platform for Medical Documents

The Company has designed the Service to enable medical documents created using the same to be exchanged as standardized data in various situations (compatible with HL7-FHIR*, etc.). In the future, the Company aims to expand its social role as a reliable documentation service that will also contribute to the electronic submission of public medical documents, in line with government policies.

*HL7-FHIR (Fast Healthcare Interoperability Resources): One of the new international standards for healthcare information exchange. It aims to facilitate data exchange between different healthcare systems and promote the sharing of healthcare information.

■ Alignment with Medical DX Policy and Institutional Integration

Electronic medical record information sharing services (Three Documents and Six Information Items) are being strongly promoted by the government as part of its medical DX policy. In the future, electronic information sharing is also being considered for public documents other than the “Patient Referral Document” included in the Three Documents. As outlined in the overall picture of the National Medical Information Platform published by the Ministry of Health, Labour and Welfare, the Service will play a key role as a platform that can securely and quickly submit data that should be managed by the government electronically, including “notification of designated intractable diseases”, “vaccination records”, and “notification of infectious diseases”.

4. Outlook

The impact of this matter on this fiscal year’s results is expected to be minimal. However, the Company believes that it will contribute significantly to enhancing its corporate value over the medium to long term. Should any matters arise require further disclosure, the Company will promptly make an announcement.
